- Works produced by generative AI : output



- A human creation (a work of the mind)
- Originality : must reflect the author's personality, the author's personal touch, skill and judgment
- The work must be fixed in a tangible medium of expression





- New York Times vs Open AI (ChatGPT)
  - Use of articles without mention of sources, without prior authorization and for commercial purposes
  - Undermining the credibility of sources
- Authors and publishers vs Anthropic (Claude) for copyright infringement
  - Posting lyrics without prior authorization
  - Reproducing literary works

(...) Article 53

**Obligations for providers of general-purpose AI models** 


- art. 53, 1, c) (Providers of general-purpose AI models) put in place a policy to comply with Union law on copyright and related rights, and in particular to identify and comply with, including through state-of-the-art technologies, a reservation of rights expressed pursuant to Article 4(3) of Directive (EU) 2019/790
- art. 53, 1, d) draw up and make publicly available a sufficiently detailed summary about the content used for training of the general-purpose AI model, according to a template provided by the AI Office


